The user shall be completely responsible for all charges, fees, duties, taxes, and assessments arising out of the use of the services. Payments: For all the services contracted, certain advance payment should be made to hold the booking, on confirmed basis. Management personnel's hold the right to decide upon the amount to be paid as advance payment, based on the nature of the service & the time left for the commencement of the service.

Mode of Payment: Payment can be made through Online Transfer to our bank / Cheque / Cash / Online payment

Cancellation Policy: In the event of cancellation of tour / travel services due to any avoidable / unavoidable reason/s we must be notified of the same in writing. Cancellation charges will be effective from the date we receive advice in writing, and cancellation charges would be as follows:

- 45 days prior to arrival: 20% of the Tour / service cost
- 15 days prior to arrival: 50% of the Tour / service cost
- 07 days prior to arrival: 75% of the Tour / service cost
- 48 hours prior to arrival OR No Show: No Refund

Note: Written cancellation will accept on all working days, except Sunday, Any cancellation sent on Sunday's will be considered on next working day (Monday). In case you cancel the trip after commencement, refund would be restricted to a limited amount only which too would depend on the amount that we would be able to recover from the hoteliers/ contractors we patronize. For unused hotel accommodation, chartered transportation & missed meals etc. we do not bear any responsibility to refund.

Our Liabilities & Limitations: Please note that after the finalization of the Tour/ service Cost, if there are any Hike in entrance fees of monuments / museums, Taxes, fuel cost or guide charges – by Govt of India, the same would be charged as extra.
