

## **Privacy Policy**

Adventure and Thrills maintains the confidentiality, security and integrity of personal information that we obtain from our users.

Adventure and Thrills uses the information you provide about yourself when placing an order only to complete that order. We are required to collect this information in order to complete your travel documents. We do not share this information with outside parties except to the extent necessary to complete your reservation.

Personal information collected by Adventure and Thrills is stored in secure operating environments that are not available to the public. You should always be careful when distributing your personal information in this manner.

We use return email addresses to answer the email we receive. Such addresses are not used for any other purpose and are not shared with outside parties.

You can request our catalog, as well as updates about our products and services. Information you submit via our website will not be used for these purposes unless you request them.

Adventure and Thrills may provide aggregate statistics about our customers, sales, traffic patterns and related site information to reputable third-party vendors, but these statistics will include no personally identifying information.

### **Making a Purchase**

In order to purchase travel and/or related services through our Website, you must provide us with certain Personal Information such as your name, credit card number and

expiration date, credit card billing address, telephone number, e - mail address and the name or names of the person(s) traveling (if not you). We may also ask you for other Personal Information, such as your frequent traveler numbers. We require this information to process, fulfill and confirm your reservations and transactions and keep you informed of each transaction's status. If you are making a reservation for one or more travelers other than yourself, you must confirm and represent that each of these other travelers have agreed, in advance, that you may disclose their Personal Information to us.

Adventure and Thrills respects your privacy and recognizes the need to protect the personally identifiable information (any information by which you can be identified, such as name, address and telephone number) you share with us. We would like to assure you that we follow appropriate standards when it comes to protecting your privacy on our web sites.

Some of our web pages use "cookies" so that we can better serve you with customized information when you return to our site. Cookies are identifiers, which a web site can send to your browser to keep on your computer to facilitate your next visit to our site. You can set your browser to notify you when you are sent a cookie, giving you the option to decide whether or not to accept it. The information we collect and analyze is used to improve our service to you.

There are times when we may collect personal information from you such as name, physical address or telephone number. It is our intent to inform you before we do that and to tell you what we intend to do with the information. Generally, you will have the option not to provide the information, and in the future you will be able to "opt out" of certain uses of the information.
